You agree to abide by the preventative measures put in place by the Event Host, and governmental agencies, to reduce the spread of COVID-19, and further understand that the Event Host cannot guarantee that you will not become infected by your participation in our event. The Event Host reserves the right to remove you from our event location, venue, and or vehicles if you, your guests, fail to follow our rules, regulations and guidelines.

I DO HEREBY AGREE TO FOLLOW ALL OF THE EVENT HOSTS AND GOVERNMENTAL RULES, REGULATIONS AND GUIDELINES AND UNDERSTAND THAT MY FAILURE TO DO SO CAN RESULT IN THE REMOVAL OF ME AND/OR MY GUESTS FROM THE VENUE, LOCATION OR EVENT.
